BayCare Physician Partners ACO was established to enhance care coordination, improve patient outcomes, and reduce costs. The ACO Board of Directors has made a *bona fide* determination that the below services are reasonably related to the purposes of the Medicare Shared Savings Program and has duly authorized these arrangements under the ACO Participation Waiver effective 06/01/2022.

- Population Health System. This is a shared data system that provides analysis and performance reporting on the ACO's patient population. The system allows the ACO to identify patients with care opportunities and monitor the quality and cost/utilization performance of ACO participants and eligible Outside Parties. The ACO and the system Vendor provide support to integrate data from Payors, ACO participants, and eligible Outside Parties into the system to produce meaningful data and analytics. This arrangement includes management of user access to the system, ticketing and service request support, development of dashboard interfaces, and education and training for end-users. This arrangement provides transparency and promotes accountability for the quality and overall care of ACO-assigned Medicare beneficiaries, which assists the ACO in improving and meeting quality performance standards of the Medicare Shared Savings Program.
- Clinical Data Registry. This is a data registry that provides insight into the clinical performance of ACO participants based on standard measures of care. The registry allows ACO participants to understand their quality performance relative to a peer cohort and identify patients with care opportunities. This arrangement includes management of user access to the registry, ticketing and service request support, development of dashboards and customized measures, and education and training for end-users. This arrangement provides transparency and promotes accountability for the quality and overall care of ACO-assigned Medicare beneficiaries, which assists the ACO in improving and meeting quality performance standards of the Medicare Shared Savings Program.
- Centralized Quality Reporting. This represents centralized services provided by the ACO to meet annual quality reporting requirements of the Medicare Shared Savings Program and Quality Payment Program. These centralized services allow the ACO to meet certain reporting requirements on behalf of ACO participants, including CMS Web Interface (formerly 'GPRO') and CAHPS for MIPS reporting. This arrangement includes technical understanding of ACO quality measure specifications, clinical review and abstraction from medical records, coordinating requests to ACO participants for clinical documentation, submission of data to Medicare, and CAHPS for MIPS vendor selection and authorization. This arrangement allows for efficient and timely quality reporting and surfaces opportunities to Improve performance, which assists the ACO in improving and meeting quality performance standards of the Medicare Shared Savings Program.

- Care Coordination Services. This represents centralized care coordination services provided by the ACO including direct outreach to members and providers to facilitate scheduling and coordination of services, member education and support, closing gaps in care, medication review and reconciliation, among others. The centralized care coordination team intervenes with the ACO's patient population to support health maintenance, transitions of care, complex care coordination, community social support, among others. This arrangement allows for greater care coordination across the continuum of care, enhances delivery of preventative care services, and leads to improved quality and overall care of ACO-assigned Medicare beneficiaries. This assists the ACO in improving and meeting quality performance standards of the Medicare Shared Savings Program.
- Risk Adjustment Program. This represents centralized outpatient clinical document improvement services. The Program was established to support complete and accurate clinical documentation, coding, and billing practices across the ACO. The centralized risk adjustment team provide support, including audit functions and training and education, to ACO participants and eligible Outside Parties. This arrangement leads to more accurate risk scores and identification of ACO-assigned Medicare beneficiaries who can benefit from care interventions. This assists the ACO in improving and meeting quality performance standards of the Medicare Shared Savings Program.
- Quality Improvement Program. This represents centralized quality improvement and
  practice transformation services. These resources provide ACO participants and eligible
  Outside Parties with performance reporting, education and training, pre-visit chart review
  forms, and actionable data to improve quality of care and contain costs. This arrangement
  leads to enhanced provider engagement and improved care delivery for ACO-assigned
  Medicare beneficiaries. These resources assist the ACO in improving and meeting quality
  performance standards of the Medicare Shared Savings Program.
- Network Development. This represents development and maintenance of BayCare Physician Partners (BPP) as a clinically integrated delivery network. Network governance and oversight, data and analytics, incentive modeling and distribution, information systems support, and performance monitoring contribute to BPP and its ACO participants as a high-quality network that provides coordinated, cost-effective services to ACO-assigned Medicare beneficiaries. This arrangement ensures that BPP and its ACO participants provide sufficient access, support a positive member experience, and provide for the robust needs of ACO-assigned Medicare beneficiaries. This assists the ACO in improving and meeting quality performance standards of the Medicare Shared Savings Program.
- Clinical Programming. This represents development of new clinical programs and the
  enhancement of legacy clinical programs. Clinical programs are developed to support
  BayCare Physician Partners (BPP) and its ACO participants in the delivery of care using the
  latest evidence-based practice and standards of care. This arrangement leads to improved
  population health, disease management, and care coordination for ACO-assigned Medicare
  beneficiaries. Clinical programs assist the ACO in improving and meeting quality performance
  standards of the Medicare Shared Savings Program.
- BayCare Purchasing Partners. Participating ACO providers have access to the BayCare
  Health System's supply contracts and distribution partners. This provides options for
  discounted prices for medical and non-medical supplies via a group purchasing model while
  assuring quality. This assists the ACO participants in meeting cost reduction goals of the
  Medicare Shared Savings Program. (Added 10/12/22)
